Description:

The policy analyst will be working in the Texas Public Policy Foundation's Armstrong Center for Energy & the Environment and the Center for 10th Amendment Studies. The policy analyst will engage in research, writing, project management, policymaker education, outreach, and public and media communications on energy, environmental and 10th Amendment issues for the Foundation. The goals of the Armstrong Center for Energy and the Environment are to promote free market principles in the development of energy policy in the state, to protect such policies where they exist, and to establish policies that protect the environment with the least interference in the marketplace. The goal of the Center for 10th Amendment Studies is to develop strategies for the state to re-establish federalism as defined in the U.S. Constitution. These Centers work closely with policymakers in Texas and across the nation to further the goals of the Centers and the Foundation.

Responsibilities include, but are not limited to:
