Description:

The policy analyst in the Texas Public Policy Foundation's Center for Effective Justice engages in research, writing, project management, policymaker education, outreach, and public and media communications on juvenile corrections issues for the Foundation and its Right on Crime initiative. The goals of the Center are enhancing public safety, empowering victims, reducing costs to taxpayers, and limiting the scope of criminal law to wrongful conduct. The Center has worked closely with policymakers in Texas and across the nation to develop and implement cost-effective alternatives to incarceration that also reduce crime, restore victims, and strengthen families and communities.

Responsibilities include, but are not limited to:

- Researching, analyzing and making recommendations on the Foundation's policy issues
- Effectively communicating the Foundation's policy recommendations to key stakeholders, including legislators, their staff and the media
- Working with other organizations throughout the country
- Project management and coalition building
- Writing policy briefs, perspectives, research studies, commentaries, testimony, and blog postings

- Organizing various policy events/activities designed to educate policymakers, stakeholders, the media, and the general public
