Let People Prosper TPPF Recommendations vs. The Legislature's

The Problem

The State of Texas spends too much and Texans are paying skyrocketing tax bills.

Attempted Solution

The Texas Legislature has gotten the ball rolling and both chambers propose essential property tax reform. However, the House and Senate's 2020-21 budgets exceed the Conservative Texas Budget (CTB). The House allocates \$9 billion to public education and temporary tax relief, while the Senate allocates \$6.3 billion to public education and temporary tax relief.

A Better Strategy

The Conservative Texas Budget sets limits on the state's 2020-21 total budget growth to no more than population growth plus inflation of 8 percent. Within this constraint, we recommend limiting general revenue (GR) spending at 4 percent, or \$4.5 billion this session, and using 90% of the remaining GR, or \$4.1 billion, to permanently compress the maintenance and operations (M&O) school district property tax rates each session until that tax is eliminated.

Why the TPPF Plan?

- Texans are paying excessive taxes as the 2018-19 budget is up \$15 billion higher than if increased by population growth and inflation since 2004.
- The Conservative Texas Budget sets maximum appropriations limits based on population growth plus inflation to slow the growth of state spending to within the average taxpayer's ability to pay.
- Texas could make history in 2019 by passing the third consecutive Conservative Texas Budget.
- Texans can obtain lasting, meaningful property tax relief by slowing excessive state and local spending growth and using state surplus revenue to eliminate M&O school district property taxes.
